Highway Use Tax Filing Deadline



Trucking fleet operators are reminded that the filing period for your Heavy Highway Vehicle Use Tax Return began on July 1 and the return is due on September 3. This deadline has been extended for 2019 because the normal filing deadline (August 31) falls on a Saturday and the following Monday (September 2) is Labor Day.

Any business or individual that has registered or is required to register a heavy highway motor vehicle with a taxable gross weight of 55,000 pounds or more in their name at the time of first use on the public highways during the reporting period must file Form 2290, Heavy Highway Vehicle Use Tax Return. Those companies with 25 or more taxed vehicles must file their Form 2290 electronically.
