The Latest "Spoofing" Scam Appears to Come from the Corner Office

That email from the boss asking for personal data on employees could be a fraudulent attempt to steal their identities. That's the warning from the Internal Revenue Service (IRS) on the latest online "spoofing" scam to rear its ugly head.

The IRS issued an alert to human resources and payroll professionals to warn them about a scheme that uses email - purportedly from company executives, but actually from cyber criminals posing as executives - to request employees' personal information. The data requested often includes

payroll records, including W-2 forms, which include employee Social Security numbers. Stolen Social Security numbers can be used to file fraudulent tax returns and claim refunds that rightfully belong to the taxpayer whose identity was appropriated.
