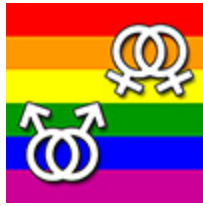

IRS Lags Other Federal Agencies in Issuing Same-Sex Marriage Guidance

Several federal agencies have updated their policies in the wake of the Supreme Court ruling on same-sex marriages. Now all eyes await clarification from the IRS on whether it will use place of residence or place of marriage in accepting joint tax returns filed by same-sex spouses residing in states that don't recognize their marriages. The impending deadline on 2012 tax extensions may pressure the IRS to act soon.
