#### This Month's Feature Spotlight: Cash Management

**Did you know you can link credit card transactions with employee expense reports?** Read on for some highlights on this efficiency-boosting feature!

- Have credit card transactions flow from Cash Management to Employee Expenses, where you can easily include them in expense reports for faster data entry. If you use a corporate card for expenses, this feature helps automate your employee expense creation process.
- How It Works
  - Enable your credit card to be used with employee expenses.
  - Then, when you enter non-billable credit card transactions, you can associate a line item with an employee. These transactions then become available for selection in an expense report for that employee.
  - After you create credit card transactions, they post to an employee expense clearing account until you code them to the appropriate expense account in the expense report.
  - For added flexibility, you can split a single credit card transaction into separate expense lines on the expense report. For example, you can split a credit card transaction for airfare and meals into different expense categories on the expense report.
  - For increased automation, set up a Cash Management creation rule to create credit card transactions automatically, based on data that arrives in the system from a bank feed or bank transaction import file.
