

This Month's Feature Spotlight: New Release Feature - Automated Transaction Matching for Purchasing Workflows - Expanded Early Adopter Program

Let Sage Intacct create draft vendor invoices for you and match them to existing purchasing transactions, with **Automated Transaction Matching for Purchasing Workflows**.

With automated transaction matching, you define how incoming purchasing documents map to existing source transactions in a one-time setup. Then, instead of converting purchasing transactions to vendor invoices, you let Sage Intacct match incoming vendor invoices, using the following flow:



- 1. You email or upload vendor invoice documents for automated processing.
- 2. Sage Intacct uses artificial intelligence (AI) to detect the vendor and match the vendor invoice to a purchasing transaction.

- 3. The system creates a draft vendor invoice for you, with the source document attached.
- 4. You review the draft transaction, validating it against the vendor invoice and making corrections as necessary, and then post.
- 5. Your corrections are fed back to the AI engine, where it updates the machine learning model to improve future matches.
