Latest Decision Creates New Deadline for Corporate Transparency Act Compliance



The on-again/off-again requirement for businesses to file a report of Beneficial Ownership Interest (BOI) to comply with the Corporate Transparency Act (CTA) is on again.

A series of back-and-forth injunctions in a Texas federal court has left companies unsure about when to file their corporate

information with the Financial Crimes Enforcement Network (FinCEN). The latest court decision, announced on February 18, 2025, has reinstated the CTA's filing requirement after a pause of several weeks.




