As we continue to enhance your AP Automation experience, we're excited to announce smarter email capabilities designed to streamline your accounts payable processes and improve communication. Last release, we introduced a new email domain that brings highly requested features such as auto-forwarding rules, expanded file format support, and enhanced notification options when documents do not get processed.

Upcoming Change:

In February 2026, all companies will be automatically moved to the new email domain for AP Automation. Want to get a head start? 1. Go to **Accounts Payable > Setup > Configuration** and find the **Bill automation settings**
2. Select **Configure** next to **Email services**.
3. Select **Send to the following address**.
4. Enter the email address where you want to receive bounce-back notifications.
5. Select **Save**.

Once your AP Automation email addresses end in **@ai.sage.com**, Sage Intacct will send a copy of any bounce-back notifications to your chosen email address.

Get Smarter Email Capabilities Now:

After your company is switched to the new email domain, your automation email addresses will change from **@sagemail.com** to **@ai.sage.com**. To view your new addresses:

- Go to **Accounts Payable > Setup > Configuration** and find the **Bill automation settings**
- Select **Configure** next to **Email services**.

Already Using AP Automation?

You can opt in to the new email service now by logging a support case. After Support confirms your switch, you'll see your new email addresses in the configuration section. Please notify any vendors who send invoices directly to your automation email address about the change. Documents sent to the old address will still be processed for a limited time, and senders will be notified of the new address.

New to AP Automation?

All companies subscribing to AP Automation after May 2025 are automatically set up on the new email service—no extra steps needed! Your email address domain will be @ai.sage.com.
